I would like to submit the following public comment for the 2/2/2023 SCUSD Board Meeting:

My name is Kendra Nickel-Nguy and I am an SCUSD parent. I have a child who will turn four in mid-April of 2023. He misses the cut-off for TK in the 23-24 school year by two weeks. He has an IEP through the school district and receives services. I have another child who met the cutoff for TK in the 2021-22 school year and had an excellent experience. A quality SCUSD TK education was immensely helpful in kindergarten-readiness.

I would like my second child to attend TK at the school my older child goes to, so he can start working with the special-needs providers that he will have in the following grades. If that is not possible, I would like him to be admitted to another TK program that is under enrolled.

I understand that each year, TK programs in the district operate below capacity. I also understand there is currently no cut-off waiver process, even though state law allows for one. I strongly urge the board to adopt a plan that allows students who miss the cut-off, but who would make the cut-off if the universal TK program were already fully implemented, to get access to a TK education. Such a plan would have a minimal financial impact on the district and a huge educational pay-off for students.

This public comment is for the February 2, 2023 SCUSD Board Meeting:

My name is Ari Asher and my child turns 4 in mid-April of 2023, missing the TK cut off by mere days. My understanding is that the TK programs operate below capacity. I am submitting this comment in hopes that the Board considers a plan to allow students who miss the current cut-off, but would otherwise have made the cut-off once the TK program is fully established, to access TK classrooms. Adoption of this plan would not bring additional costs to the District, and would instead allow many students the opportunity to access early education.


Moreover, time is of the essence. As a parent working hard to plan for my child's educational future, it would be helpful to know sooner, rather than later, whether SCUSD will maximize the impact of the state's universal TK initiative.

Good morning,

I am writing to update you on recent public communications from the California Dept of Public Health (CDPH) regarding California covid injection mandates for school. Essentially, CDPH has sent email communications stating they have no intention of pursuing a regulatory channel for school covid injection mandates after the state of emergency ends on February 28, 2023. They have stated that the proper avenue for this mandate would be the CA legislature. Since no such bills have been introduced this legislative session, and last year's effort on Senator Pan's SB871 failed so miserably, and this year there are even more people opposed to this mandate than last year, it is time for SCUSD to update it's policies and website accordingly.

Therefore, it is time for SCUSD to (1) rescind SCUSD's October 12, 2021 resolution illegally mandating COVID injections for students and (2) correct all the misrepresentations on the SCUSD website indicating these injections are mandated for students, staff, teachers, volunteers or substitutes.

As you know, the Governor illegally declared in the fall of 2021 that all

kids were going to be mandated to get the covid injections for school. Several school districts were selected to "test drive" these illegal mandates, spawning lawsuits to be filed in various courts, and those lawsuits were all ultimately successful in de-activating these mandates in those districts. SCUSD was never sued in court, so their illegal mandate imposed by way of a Board Resolution dated October 12, 2021, remains on the books. In addition, the SCUSD website is saturated with numerous erroneous and illegal statements of covid injection mandates for students and staff.

Recently, in November 2022, one of these lawsuits out of San Diego was appealed to the 4th District Appellate Court, and the panel struck down the school district mandates, finding that they are preempted by state law and local school districts have no legal authority to push these mandates. See this article from the San Diego Union-Tribune citing the Appellate court's ruling. The appellate ruling is binding law on all lower courts in California:

Since the FDA has not, and is reportedly not planning to approve the covid injections for kids given the lack of effectiveness of the injections in studies, as well as increasing documented adverse events showing shocking lack of safety, efforts to mandate the vaccine in the legislature fell flat last year, and opposition is increasing all the time, with more and more experts opposing these vaccines for young people every day.
