Re: Reopening of School Negotiations

Dear Mr. Borsos:

We appreciated the opportunity to discuss the District's distance learning proposal with SCTA on Tuesday, July 28, 2020. At the negotiations session last evening, we reviewed our distance learning proposal with SCTA. Near the conclusion of the session, SCTA shared a list of discussion points. Also, at the end of this session, SCTA proposed that the parties meet again on Thursday, August 6, 2020 regarding distance learning to receive SCTA's counter-proposal. The District accepts the Thursday, August 6, 2020, date for negotiations. We also propose that the parties meet again even sooner because time is of the essence.

During the final portion of our meeting last night, SCTA shared a general concept on a process that involved nine (9) work groups meeting with the District's team to further discuss elements of our distance learning proposal. We believe that the suggested process on working groups can be accomplished with SCTA's negotiations representatives for the various grad spans and specialty areas in your work group proposal sharing their feedback and asking questions on the District's distance learning proposal. This will allow the parties to efficiently continue collaboration on the reopening of schools within the appropriate negotiations structure.

Because we are committed to providing the clarity that our community and staff deserves regarding the distance learning program that will be in place when school opens on Thursday, September 3, 2020, we agree to hold meetings with SCTA representative from the various grade spans and specialty areas on Monday, August 3, and Tuesday, August 4, 2020, based on the schedule below.

Monday, August 3, 2020

10:00 A.M. Primary; 11:45 A.M. Intermediate; 1:30 P.M. Middle School; and 3:15 P.M. High School.

Tuesday, August 4, 2020

10:00 A.M. PE; 11:45 A.M. SPED; 1:30 P.M. CTE; 3:15 P.M. Child Development; and 5:00 P.M. Music.

Please confirm that the above schedule is amenable to SCTA on or before **close of business today, Wednesday, July 29, 2020**. Again, we look forward to moving through this process and receiving SCTA's counter-proposal at the August 6, 2020 negotiation session so that we have a distance

learning plan in place well before school begins on Thursday, September 3, 2020. Should it be necessary, we also ask that SCTA hold Friday, August 7, 2020 to continue negotiations so that we can reach an agreement and begin the implementation phase of our distance learning program.
